## **Loading Instructions**

### **For Commodore 64™**

- Plug in Commodore MPS801 or Okimate 10 graphics printer. (Optional)
- Turn on computer and disk drive.
- Insert disk, label side up, into disk drive.
- Type LOAD "", 8, 1 and press RETURN.

### **For Commodore 128™**

- Plug in Commodore MPS801 or Okimate 10 graphics printer. (Optional)
- Turn computer and disk drive on.
- Insert disk, label side up.
- Type GO 64; press RETURN. Then type LOAD "", 8, 1 and press RETURN.

### **For Apple II Series Computers**

- Plug in LX80, Imagewriter or other compatible graphics printer. (Optional)
- Insert disk, label side up, into drive.
- Turn on equipment.

### **For Atari 800, XE, XL and Compatible Computers**

- Plug in LX80, Okimate 10 or other compatible graphics printer. (Optional)
- Insert disk, label side up, into drive.
- Turn on disk drive and computer.

### **For Apple® Macintosh™**

- Plug in Imagewriter printer.
- Insert disk, label side up.
- Turn on computer.

### **For Atari® ST™**

- Plug in LX80 or FX80 printers.
- Insert disk, label side up.
- Turn on computer.

### **For Amlga™**

- Plug in LX80 or compatible graphics printer.
- Turn on computer.
- Insert Kickstart disk.
- When instructed to insert the Workbench disk, simply insert the Hacker™ disk.

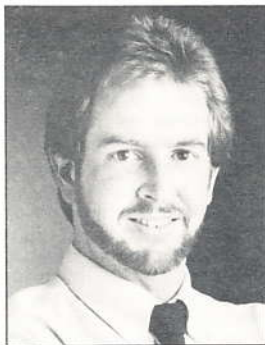
